ABSTRACT

Labour, Employment, Training & Factories Department – The Building and other Construction Workers (RE&CS) Act, 1996 – Implementation of Welfare Schemes by the Telangana Building and Other Construction Workers Welfare Board – Enhancement of the relief amount from Rs.3,00,000/- to Rs.5,00,000/- for total permanent disability and from Rs.3,00,000/- to Rs.4,00,000/- for partial permanent disability to the registered building & other construction workers – Orders – Issued – Orders – Issued.

ORDER:

In the G.O. 1st read above, the Government have issued orders to enhance the existing amount from Rs.2,00,000/- (Rupees two lakhs only) to Rs.3,00,000/- (Rupees three lakhs only) towards relief to registered building & other construction workers who met with an accident either in the work place or anywhere else resulting in total permanent disability / partial permanent disability in terms of sub Rule (L) of Rule-33 of the Andhra Pradesh Building and Other Construction Workers (RE&CS) Rules, 1999 read with section 22 of the Building & Other Construction Workers (RE&CS) Act, 1996 with certain guidelines as mentioned therein.

2. In the circumstances reported by the Secretary & Chief Executive Officer, Telangana Building & Other Construction Workers Welfare Board, Hyderabad, in the reference 2nd read above and after careful examination of the proposal, Government hereby order to enhance the relief amount from Rs.3,00,000/- (Rupees three lakhs only) to Rs. 5,00,000/- (Rupees five lakhs only) and from upto Rs.3,00,000/- (Rupees three lakhs only) to upto Rs.4,00,000/- (Rupees four lakhs only) to the registered building & other construction worker sustaining injuries caused by an accident occurring either in work place or anywhere else resulting in total permanent disability and partial permanent disability respectively. The extent of the disability relief shall be decided as per the procedure laid down under Employees' Compensation Act, 1923, with the following conditions & guidelines for implementation of the Scheme w.e.f 01.05.2016:-

- (i) The Scheme is applicable to the registered building and other construction worker as a beneficiary with the Board.
- (ii) The enhanced amount under the disability relief is applicable only to the accident that taken place on or after 01.05.2016.
- (iii) Relief under this scheme is in addition to other relief / compensation that the worker may be entitled to under any other Scheme.
- (iv) The registered worker shall submit prescribed application form to the concerned Asst. Labour Officer along with Adhar Card, Disability Certificate issued by the Competent Authority, FIR if the case is registered with the police and any other relevant documents in support of their claim.

- (v) The Deputy Commissioner of Labour concerned shall obtain enquiry report from Assistant Labour Officer concerned and place before the District Scrutiny Committee for its scrutiny.
- (vi) After scrutiny, if found eligible, the relief amount shall be released to the saving bank account of the registered building & other construction worker.
3. The Commissioner of Labour, Telangana, Hyderabad and the Secretary & Chief Executive Officer, Telangana Building & Other Construction Workers Welfare Board, Hyderabad shall take necessary action accordingly.
4. This order does not require concurrence of Finance Department as per rules in force.
